President's Message

Bill Christ

This is an article from Jim Olszynski that was first published in the Plumbing & Mechanical magazine in October, 2010. It is with his permission that I have it reprinted for you.



You won't often find in this space praise for government bureaucrats, but let's give credit where it's due. Late last July California's Contractors State License Board (CSLB) mounted an undercover sting operation in conjunction with San Diego law enforcement agencies and the California Department of Insurance that nabbed 13 violators of the state's home improvement licensing laws. Four HVAC contractors and one plumbing contractor were among them. Bravo!

Sure, a cynic could point out that the busted trades people represent on a miniscule percentage of unlicensed contractors operating in the state or even in the San Diego area. Yet by publicizing the sting to both the trades press and general news media, the CSLB's action makes it reverberate far beyond the individuals who got caught. Publicity causes all unlicensed contractors to look over their shoulders. This is the type of activity that licensing boards ought to be doing more of, along with publicity campaigns that inform home and building owners about the dangers

of using unlicensed trades people and how to turn them in.

Unlicensed operators typically do not carry workers; compensation and professional liability insurance. Owners may be held liable if a worker is hurt on their property and left without financial recourse if something goes wrong with the project. Most property owners are totally in the dark about such things in their quest to find someone who works cheap. Some jurisdictions have mounted public awareness advertising campaigns to educate the public about the potentially costly consequences of using unlicensed trades peoples. Often these advertisements are considered public service announcements and are run for free by local media outlets.

I've also seen ads in some states notifying homeowners they are under no legal obligation to pay for work performed by unlicensed people. If this tactic became widespread, we'd likely see a steep decline in unlicensed work.

Sting operations are more complex undertakings that require considerable resources in both money and manpower. That's why they are so rare. But it's a better use of licensing agency resources than what most of them do.

This amounts mostly to a lot of paper shuffling and harassment of licensed contractors who fail to dot an "I" or cross a "t". Skewed enforcement priorities come about because contractors who play by the rules are easy to identify and scrutinize.

If you qualify for a license, pay the fee, pull required permits and call for inspections, it's easy to keep track of your activities and nitpick your jobs. It takes much more effort to uncover illegal work taking place and mete out penalties sufficient to discourage it. In many jurisdictions the most severe penalty for trade malfeasance is loss of license, but what does that matter to someone who never bothers to get one?

Licensing bureaucrats and their trade allies constantly complain about lack of funds to hire enough inspectors. However the real problem with most licensing agencies is not so much a lack of firepower as aim. Just as communities can't afford to put a cop on every street corner, there will never be enough money to inspect every jobsite, and funding shortages will only get worse given the dire state of public finances throughout the country. Instead of crying poverty, licensing authorities need to be more imaginative in finding ways to get the biggest bang for their bucks. Public awareness campaigns and sting operations can achieve more than a couple of extra inspectors in protecting the public and knocking unlicensed tradespeople out of their comfort zone.

Laws that go unenforced are worse than no laws at all, because they engender disrespect for the law. Where licensing laws are routinely circumvented with little threat of penalty, those jurisdictions might be better off with no licensing at all. At least that way the conscientious contractors would have a level playing field with those who don't give a hoot.

Let's also remind ourselves that the ranks of inspectors could be increased by tens of thousands at no additional cost if duly licensed contractors would take it upon themselves to self-police their trades. Legitimate contractors and their crews are plugged into the local grapevine and often know of work that's taking place on the sly by people without proper credentials.

There's a time and a place for "mind your own business," but this isn't one of them. Take a deep breath and start blowing that whistle. Your industry, your business and public health and safety will all be better off because of it.

Editor's note: MPMCA has addressed the problem of unlicensed contractors by sponsoring and enacting in 2002, Act 733 P.A. 2002. These major revisions to the plumbing licensing statute in Michigan have led to an extensive number of license revocations, suspension, restitutions, and prosecutions of unlicensed persons. The Plumbing Division of the Bureau of Construction Codes has indicated the revision to the Plumbing licensing act are to be credited for these improvements. We continue to encourage plumbing contractors to be observant of local unlicensed activities and report such activities to authorities.

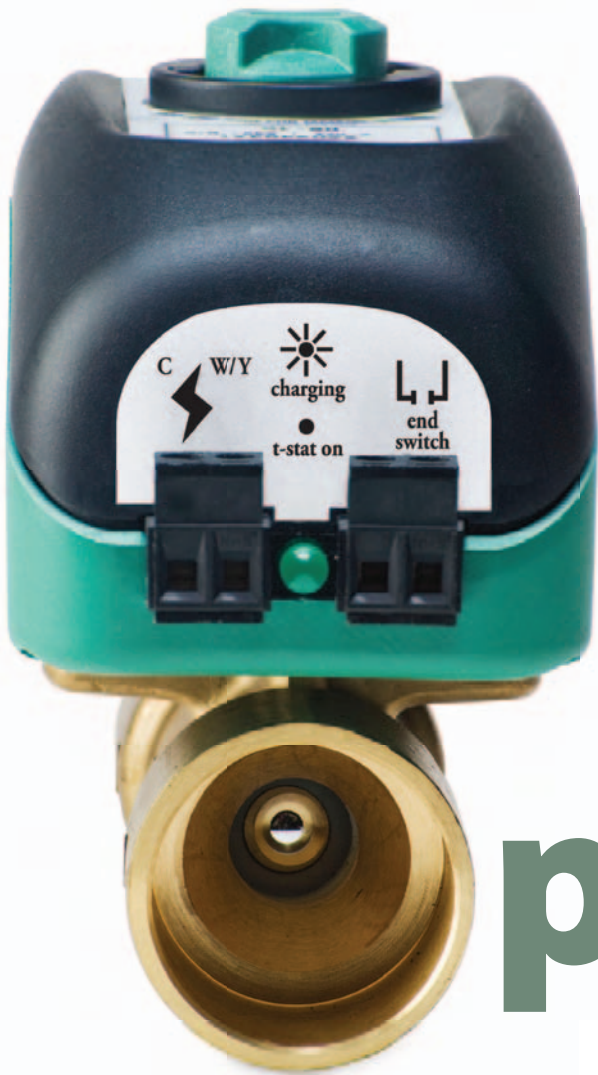

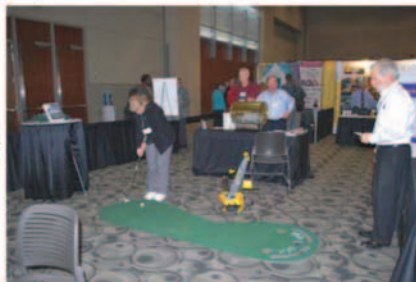


MASB Exhibit Show

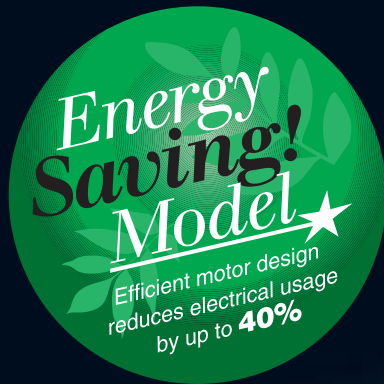

2009 MICHIGAN PLUMBING & RESIDENTIAL CODE UPDATES

Required For All Master and Journey Plumbing Licensees

The 2009 Michigan Plumbing Code Became Effective Aug. 20, 2010

Under the requirements of Act 733 Public Acts of 2002, all journey and master plumbers are required to attend a **five-hour** Michigan Plumbing & Residential Code update **within 12 months** of a code update as a condition of license renewal (**Before August 20, 2011**).

MARCH 30, 2011, Soaring Eagle Resort

WHY SHOULD YOU ATTEND?

If you are a licensed journey or master plumber, you must attend a State Plumbing Board approved five hour code update class before August 20, 2011 for the **2009 Code Edition** and be able to verify your attendance to the Plumbing Division before your license can be renewed in the future.

After the code update class, all attendees who complete the five-hour class will have a certificate to take with them for their records.

REMEMBER: THE PLUMBING LAW REQUIRES ALL LICENSEES TO COMPLETE THE REQUIRED FIVE HOUR CLASS WITHIN ONE YEAR OF THE CODE UPDATE.

The code update class is open to all journey master plumbers and to inspectors who need the class as a condition of license renewal. Inspectors will also receive five hours of technical credit under the inspector's registration law, Act 54.

Chief Plumbing Inspector for the State of Michigan Bob Konyndyk will conduct the session.

The new commercial plumbing code went into effect on August 20, 2010. The Residential Code goes into effect on a later date but will be updated at this seminar. Many questions have arisen, as the code will be used in the field. This will be your opportunity to have those questions answered.

It's Smooth Sailing for Busy Marina Bathhouses, Thanks to Powerful, Reliable Macerating Plumbing

Lake Michigan marina outfits two floating, 600-square-foot bathhouses, each with six bathrooms and a laundry room, and equipped with macerating plumbing to avoid system failures during peak usage by the general public.

When the Hammond Marina on Lake Michigan opened for the season in May 2009, boaters were greeted with a pair of new dockside conveniences: two floating bathhouses, each with six bathrooms and a laundry room. You wouldn't know it, looking at them nestled into the dock today, but the ADA-compliant, 15-foot x 42-foot facilities were built in a factory more than 400 miles away and trucked to Indiana on an 18-wheeler.

Installing the bathhouses was a much-needed upgrade to the main dock, and customer satisfaction was the project's top priority for the Hammond Port Authority. To help meet that goal, the authority brought in Deborah Natrass to oversee the complex job. Natrass is co-owner of Product Link, Inc. and Nautical Nature, Inc., both of which specialize in marina products in California and the Great Lakes areas.

Through the years, Natrass has overseen a range of marine projects that involve installing pump-out systems, docks, floating bathrooms and floating houses. For the Hammond Marina, she recognized that top-notch plumbing was key to customer satisfaction, so she opted to use Saniplus macerating toilets from SFA Saniflo Inc. in all 12 bathrooms, reducing the potential for clogging and other plumbing problems that are common in public restrooms.

"This setup is unique," says Hammond Harbormaster Keith Carey. "I'm not sure a conventional toilet would have worked. If not for the macerating pumps, I would foresee a lot of problems."

Up to 1,000 People Daily: With more than 1,100 slips accommodating watercraft as large as 80 feet, Hammond's is the second largest publicly owned marina on Lake Michigan. Two thirds of the marina's customers will rely on the new facilities. "On an average weekend, the marina will serve 800 to 1,000 people a day," Carey says.

Adds Natrass, "I've heard of harbormasters saying public baths can be a headache for marina operators, so we try to prevent that. Whenever you do a marina project, it's good to have macerating plumbing, because you don't want any issues with a floating structure. Saniflo makes the bathroom error-proof."

"First-Class Units": The late Charlie Stricker, former head of operations and maintenance for the Hammond Port Authority, conceived the project. He wanted to avoid building more structures that would block the view of the shoreline, and building on

pilings didn't achieve the aesthetic the authority wanted. "After looking at a number of options, Charlie worked with Natrass to come up with the modular bathhouses, which look more like the other structures in the marina," explains Carey, who took over the project after Stricker passed away.

Natrass had the challenging job of pulling together and supervising multiple subcontractors to carry out the complex project. She contracted with Merco Marine of Wellsburg, W. Va., to supply the platform, floats and decking to support the structures at the Marina's dock. Jon Meriwether started Merco Marine in 1979 as a part-time operation with his son. Today, the company operates from a five-acre manufacturing plant, offering a wide array of marine products.

It took nine truckloads to transport the float materials to Hammond. Meriwether's company supplied the float, platform, metal truss frames and decking. "Each bathhouse weighs 39,000 pounds," he says. "To support them, we built units 130 feet long and 30 feet wide, with 330,000 pounds of flotation. We designed the float so that it sits slightly below the dock. These are first-class units."

Meriwether, who lives in a floating house himself, was already familiar with macerating systems. In fact, his company now offers a new floating-restroom product that also features the Saniplus toilet. "I'm using maceration because I don't want the

plumbing to clog up,” he says.

It was Meriwether who researched builders for the project, helping Natrass settle on Modular One in Pulaski, Tenn. That company system-built the bathhouses on-site and handled their transport to Indiana.

Early on, macerating toilets emerged as a key to the project’s success. “I’ve sold floating structures previously, and Saniflo macerating products have the best name and reputation. They are excellent for marine application,” Natrass explains. “When you have a boating community with lots of people, you don’t want any plumbing problems. A regular toilet wouldn’t be sufficient in that type of application.”

Natrass recommended using Saniflo’s Saniplus model, which has a built-in grinder, thus “eliminating anything that’s coming off that structure that could back up the system,” she explains. Using small-diameter discharge piping, the Saniplus can pump effluent 15 feet vertically and 150 feet horizontally.

Even that considerable pumping distance falls well short of Hammond Marina’s unusual plumbing configuration, which requires effluent to be pumped 900 feet from the dock to the sewer. Each Saniplus toilet therefore connects to a floating tank. When the tank is filled, the contents are pumped to a larger lift station, which then pumps it to the sewer.

“The plumbing is kind of a complicated, two-stage setup,” says Carey. “The grinders seem to do a very good job of breaking down the paper and other solids to allow them to pass easily through the pumps.”

Carey notes that some of the other pumps in the marina have to be cleaned once a month, adding: “I don’t foresee any maintenance issues like that with the two new macerating systems.”

From Pulaski to Hammond: The bathhouses were fully constructed in Pulaski, with the exception of some exterior finish work done after they were placed onto Meriwether’s floats in the marina. Each bathroom has a toilet, sink and shower, and each bathhouse has two handicapped-accessible bathrooms. A laundry room and a mechanical room round out each facility.

The entire construction project took under three weeks, with Modular One’s plumbers installing the Saniflo systems. General manager Tripp Weigel was not familiar with macerating plumbing prior to the project. “We were a little nervous about macerating plumbing, but it was a fairly easy and simple installation.”

Meriwether recommends installing macerating technology in public restrooms that are heavily used on weekends. “We’ve had a positive experience with macerating toilets,” he says. “There’s a call for these in state parks and private marinas. We sell them all over the country.”

“We’ll definitely go with maceration when we do more of these boathouses,” Natrass agrees. “Saniflo has a great name out there, and their products are very user-friendly, easy to operate and easy to maintain.”

For harbormaster Carey, the proof was in his customers’ response. “I’ve been talking to all of our customers, and the feedback has been outstanding,” he says. “That’s what we’re here for — to please them and serve them. If they’re happy, I’m happy.”

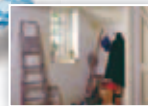

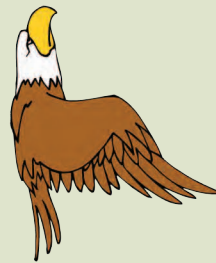

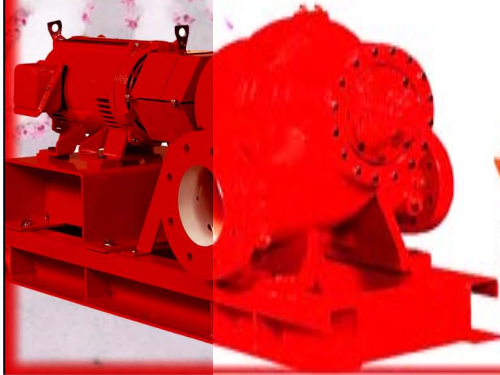

Upon satisfactory completion, Michigan licensed plumbers receive a State Approved certification for general testing and are qualified to repair or replace backflow devices. However, licensed plumbers must provide their license number and date of the license expiration. License plumbers must have current license to receive the backflow certification. If the license is expired a letter of completion will be issued limiting testing to the premises of their current place of employment.

Other graduates who are not licensed plumbers receive a letter of completion, limiting testing to the premises of their current place of employment only. They are not permitted to test in the field, install, or make repairs to backflow devices.

Participants will receive 21 hours (2.1 continuing education credits) MDEQ Division of Water Supply.

Under Act 54 – Plumbing Inspectors registration Act – Plumbing Inspectors will receive 24 continuing education credits, 16 specialty hours and 8 technical hours.
